RULES & CONDITIONS

1. The competitions are open to amateur male golfers who are 55 or over at 00:00 hours on 4th September 2020 and to female golfers who are 50 or over at 00:00 hours on 4th September 2020, in possession of a CONGU handicap, and who are members of an affiliated Golf Club in the SG North.
2. The competitions will be played in accordance with the Rules of Golf and the Rules of Amateur Status as approved by R & A Rules Limited.
3. Each competition will be over 18 holes and the lowest scores will win the various prizes.
4. Each competition is governed by the Executive of the SG North and the Executive will make decisions, and settle disputes, such decisions and settlements being final.
5. The competitions will be for males: (a) Lowest Scratch. Prizes for the winner - The Macallan Trophy and voucher for £100. Those placed 2nd and 3rd will gain vouchers for £80 and £60. (b) Scratch and Handicap prizes in each of three age classes: A (55-64), B (65-70) and C (71+) years of age. Ages are those on the day of the competition. Prizes in each class are Scratch Winner £50 voucher and Handicap 1st, 2nd and 3rd vouchers for £50, £40, and £30. Winners of the top three scratch prizes shall not also win their age-group scratch prizes. Scratch prize winners shall not be eligible to win handicap prizes in addition.
The competitions will be for females: (a) Lowest Scratch. Prizes for the winner - The North District Trophy and voucher for £100. Those placed 2nd and 3rd will gain vouchers for £80 and £60. (b) Scratch and Handicap prizes in each of three age classes: A (50-60), B (60-70) and C (71+) years of age. Ages are those on the day of the competition. Prizes in each class are Scratch Winner £50 voucher and Handicap 1st, 2nd and 3rd vouchers for £50, £40, and £30. Winners of the top three scratch prizes shall not also win their age-group scratch prizes. Scratch prize winners shall not be eligible to win handicap prizes in addition. (This is dependent on the number of entries)
6. The competitions will be played at Invergordon Golf Club on Friday 4th September 2020.
7. The closing date for entries will be Wednesday 4th September 2020 at 17:00 hours, by which time an entry, to be accepted, must be in the hands of the Secretary of the SG North. It is the responsibility of the entrant to ensure that an entry is received by the Secretary by the due time on the due date. The Secretary will be the sole arbiter of compliance with this requirement, and no correspondence nor discussion will be entered into with regard to the decision in this respect.
8. All entries must include Full Name, Address, Date of Birth, Contact Telephone Number, Email, Home Club and Exact Handicap. Forms of entry will be in the hands of all Secretaries of member clubs in the SG North not later than 28 February 2020. Similar forms will be in the hands of the Secretary of the SG North not later than 28 February 2020. The form of entry requires to be signed by the entrant.
9. The entry fee is £15 and will not be refunded in any circumstances other than balloting out hereunder.
10. Forms of entry and Rules and Conditions will be posted on the SG North Website (www.sg-north.com) by 28th February 2020 and may be downloaded.
11. A competitor is not permitted to withdraw at any stage of the competition except for emergency reasons or medical circumstances explained to and accepted by the Executive. A competitor failing to notify the Executive in person of his withdrawal before departing the competition venue will be subject to an automatic one year ban from all SG North events, such ban also to apply if such withdrawal is not accepted as aforesaid. Only in exceptional circumstances and on appeal to the Executive will the ban be uplifted.
12. Late entries will be placed on a reserve list, for admission to the competition in the event of a withdrawal or otherwise at the discretion of the Executive.
13. The draw for play will be made and published on the website (www.sg-north.com) not later than Tuesday 1st September 2020. No preferred tee times will be granted. The Executive will endeavour to comply with travelling arrangements specified, but accepts no obligation to do so.
14. Caddies will be permitted and buggies may be used.
15. The Macallan Trophy and The North District Trophy remains the property of the SG North. It will be held by the Golf Club of the winner, and that winner and his Golf Club will be jointly responsible for returning it to the Secretary of the SG North, duly engraved, not later than 21st January 2020.
16. Competitors to arrange their own practice round with the club.
17. The Executive reserves the right to fix a maximum number of entries, and to ballot out in ascending order of handicap. The entry fee of an entrant balloted out will be returned.
18. A tie for the Macallan Trophy and The North District Trophy will be decided by a play-off over two holes, thereafter sudden death played immediately. Any other tie for first place will be decided by matching scorecards, otherwise known as countback. A tie for the lesser places will be decided by countback.
19. Distance Measuring Devices will be allowed.
20. The Executive reserves the right to amend or add to these Rules in order to achieve a result.
