RULES & CONDITIONS

1. The competitions are open to amateur golfers who are 18 or under at 00:00 hours on 1 January 2020, in possession of a CONGU handicap, and who are members of a Golf Club which is a member of the SG North or North East District of the Scottish Golf.
2. The competitions will be played in accordance with the Rules of Golf and the Rules of Amateur Status as approved by R & A Rules Limited.
3. Each competition will be over 36 holes male and 18 holes female and the lowest aggregates male and 18 hole score female will win the various prizes.
4. Each competition is governed by the Executive of the SG North and the Executive will make decisions, and settle disputes, such decisions and settlements being final.
5. The competitions will be Male: (a) Lowest Aggregate Scratch: Prize - H.R.Spence Trophy and a voucher for £65. (b) Second, third, fourth, fifth and sixth Scratch. Prizes respectively vouchers for £50, £40, £30, £25 and £20. (c) Lowest Aggregate Scratch under 16 at 00:00 on 1 January 2019. Prize voucher for £45 plus a crystal medal. (d) Second and third Lowest Aggregate Scratch under 16 as above. Prize vouchers for £35, £23. (e) First, second and third Lowest Aggregate Handicap. Prize vouchers £45, £35 and £23, First Handicap receives the A. Paterson Trophy. (f) Prizes under (a) and (b) above are excluded from the prize list for (c) and (d) above. Prizes winners under (a), (b), (c) and (d) above are excluded from the prize list for (e) above.
Female: (a) Lowest 18 Hole Scratch Prize - Hannah McCook Trophy and a voucher for £50. (b) Second and third Prize vouchers to the value of £25 and £20 respectively. Lowest Scratch under 16 at 00:00 on 1 January 2020. Prize voucher for £30 plus a crystal medal. Prize vouchers for £25 and £20 for Lowest U16 scratch second and third. First Handicap, receives the Elizabeth Munro Trophy plus a £30 voucher second and third receive vouchers for £25 and £20 respectively.
6. The competitions will be played at Garmouth & Kingston Golf Club on Sunday 26th April 2020.
7. The closing date for entries will be Wednesday 15th April 2020 at 17:00 hours, by which time an entry, to be accepted, must be in the hands of the Secretary of the SG North. It is the responsibility of the entrant to ensure that an entry is received by the Secretary by the due time on the due date. The Secretary will be the sole arbiter of compliance with this requirement and no correspondence nor discussion will be entered into with regard to the decision in this respect.
8. All entries must include Full Name, Address, Date of Birth, Contact Telephone Number, Home Club, Exact Handicap & CDH Number. Forms of entry will be in the hands of all Secretaries of member clubs in the North District not later than 28 February 2020. Similar forms will be in the hands of the Secretary of the SG North and North East District by the same date. The form of entry requires to be signed by the entrant.
9. The entry fee is £15 and will not be refunded in any circumstances other than balloting out hereunder.
10. Forms of entry and Rules and Conditions will be posted on the SG North Website by 28 February 2020 and may be downloaded there from.
11. A competitor is not permitted to withdraw at any stage of the competition except for emergency reasons or medical circumstances explained to and accepted by the Executive. A competitor failing to notify the Executive in person of his withdrawal before departing the competition venue will be subject to an automatic one year ban from all SG North events, such ban also to apply if such withdrawal is not accepted as aforesaid. Only in exceptional circumstances and on appeal to the Executive will the ban be uplifted.
12. Late entries may be accepted or placed on a reserve list if list full, for admission to the competition in the event of withdrawals or otherwise at the discretion of the Executive.
13. The draw for play will be made and published on the website (www.sg-north.com) not later than Tuesday 21st April 2020. No preferred tee times will be granted. The Executive will endeavour to comply with travelling arrangements specified, but accepts no obligation to do so.
14. Caddies will not be permitted.
15. All Trophies remain the property of the SG North. It will be held by the Golf Club of the winners, the winners and the Golf Clubs will be jointly responsible for returning it, duly engraved, to the Secretary of the SG North not later than 25th January 2021.
16. Competitors will be allowed the courtesy of Garmouth & Kingston Golf Club for a practice round prior booking being required.
17. The Executive reserves the right to fix a maximum number of entries, and to ballot out in ascending order of handicap. The entry fee of an entrant balloted out will be returned.

18. A tie for the Main Trophies will be decided by a play-off over two holes, thereafter sudden death played immediately. Any other tie for first place will be decided by matching scorecards, otherwise known as countback. A tie for a lesser place will also be decided by countback.
19. The competition will be run in accordance with the Child Protection Policy of the SG North, copies of which are available from the Secretary on request.
20. Distance Measuring Devices will be allowed.
21. The Executive reserves the right to amend or add to these Rules in order to achieve a result.
